Why?	Companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share, depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"><li>• Shipping and address information</li><li>• Email, phone number, and contact information</li><li>• Payment history for goods and services</li></ul>
How?	Watchtower Gaming needs to share customers' personal information to run their everyday business. In the section below, we list the reasons our company might share our customers' personal information; the reasons we choose to share; and whether you can limit this sharing.

## What we do

<b>How does Watchtower protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply industry best practices. These measures include computer safeguards, and two factor authentication wherever possible to limit exposure. We also educate employees on the importance of confidentiality and restrict as needed, employees access to your nonpublic information.
<b>How does Watchtower collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>• Submit a sign-up form</li> <li>• Purchase a Watchtower Gaming product</li> <li>• Sign-up to receive Watchtower Gaming information through a nonaffiliate</li> </ul>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>• affiliates from using your information to market to you</li> <li>• sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing. [See below for more on your rights under state law]

## Definitions

<b>Affiliates</b>	Companies related by common ownership or control. <ul style="list-style-type: none"> <li>• <i>Watchtower Gaming LLC does not currently have affiliates.</i></li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. <ul style="list-style-type: none"> <li>• <i>Watchtower Gaming relies on third-parties to fulfill orders, manage and distribute communications, and perform crowdfunding campaigns.</i></li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated companies that together market products or services to you.

## Other Important Information

You may have other privacy protections under applicable state laws including those for California residents. To the extent the state laws apply, we will comply with them when we share information about you, and in some cases may be limited by you.
